BACKGROUND INFORMATION:

On May 8, 2008, the Board approved the formation of the new FCUSD SELPA Community Advisory Committee and directed staff to begin the solicitation of applicants for the committee. Applications were emailed to the current members of the Special Education Parent Advisory Committee (SEPAC), to all special education teachers for forwarding to parents, and to principals. The committee positions were also advertised on the FCUSD website and through a press release. The initial round of applications was due at noon on June 6, 2008.
