SPECIAL PRESENTATION

Vista del Lago High School Update – John Dixon

Superintendent Godwin introduced Vista del Lago Principal John Dixon. Mr. Dixon gave the Board a brief update on the progression of the high school. He reported that over 700 parents attended an information night held at the Jill Solberg Theater.

Lead teachers and division leaders are organizing curriculum. In June, they will receive training on block scheduling. New courses will be offered. He announced that the following personnel will be on the staff at Vista del Lago: Chris Aland, vice principal; Donna Burnett, counselor; Gayle Losch, activities director; Robert Reed, athletic director; and Kelly Hillesland, Mark Keeton, Sandy Hathaway, Lori Emmington, Greg Gorbach, Lisa Johnson, and Christy Wilkerson, division leaders.

Vicki Morgan, teacher

- Teachers work beyond contract hours to improve children's learning. District test scores are near the top; teachers' pay is near the bottom.

Judith Kummer, teacher

- Asked why the District continues to use program cuts to strong-arm employees. Management is getting huge dollars while teachers aren't. Doesn't doubt management is worth it, but so are teachers.

Dale Waldo, teacher

- Teachers take pride in what they do. Asked for applause for the students and parents in the audience. Urged a fair and respectful offer now.

Cheryl Guevara, teacher

- Spoke in support of teachers and read a poem she wrote reminiscent of a Dr. Seuss story.

The Folsom Fire Marshall arrived and asked to speak with President Stanley.

President Stanley recessed the meeting at 6:32 p.m.

The Fire Marshall announced that the room capacity was 95 persons, and the number in attendance was far greater than that amount. He asked the audience to leave the building in an orderly fashion, and people would be readmitted in groups of 95 for the rest of the meeting. The majority of those in attendance refused to vacate the building.

At 6:45, Superintendent Godwin announced that the meeting was adjourned. Consent and Discussion items on this agenda will carry over to the next meeting. He requested that FCEA administration let the District know how many people to expect so that a room with sufficient capacity can be provided.
