FREQUENTLY ASKED QUESTIONS

What is Measure G?

Measure G, is a \$195 million general obligation bond program that was approved by Folsom voters in November 2014. Measure G will address the following needs:

- Complete needed repairs to provide safe, wellmaintained classrooms
- Upgrade and provide additional classroom computers and instructional technology
- Upgrade aging and inefficient electrical, heating and air conditioning systems, redirecting hundreds of thousand of dollars back to the classrooms.
- Provide classrooms and facilities to prepare students for college and success
- Provide facilities for after-school programs

How much does Measure G cost?

The maximum tax rate per property owner is averaged over the life of the bond to be \$60.00 per \$100,000 of assessed valuation, which is different from the market value of your home.

Measure G Master Plan

- ♦ The Board of Education approved an initial priority list which includes Sutter Middle School modernization/new construction, Vista del Lago bleacher/stadium project, Folsom High School auxiliary gymnasium, modernization/new construction of Oak Chan Elementary School and the modernization/new construction of Carl Sundahl Elementary School. As the initial priority list concludes, additional Measure G Master Plan projects are being completed.

MEASURE G OVERVIEW & PROJECTS

In November 2014, Folsom voters passed Measure G, a \$195 million general obligation bond for renovation, maintenance, and new construction at existing Folsom schools. Proceeds from the sale of Measure G bonds will be used to complete upgrades and repairs in the Folsom schools. Funds can only be used for Folsom schools, and cannot be used for administrative salaries or school supplies.

Measure G calls for a Citizens Oversight Committee, which has a broad-based membership, to monitor expenditures and the construction progress. All expenditures authorized by Measure G are reviewed by the Citizens Oversight Committee to ensure the money is spent only on school facility improvements, as defined by the bond text approved by the voters. Also, the committee reviews an annual audit report prepared by an independent Certified Public Accounting firm.

The Committee meets approximately every three months and its meetings are open to the public. Parents and community members are encouraged to attend. Members of the Measure G Citizens Oversight Committee are: Jennifer Lane, Ginger Sackmann, Nichole Buvert, Elvia Triki, Veronica Voldseth, Laura Ruby, and Anna Boruk. The Committee currently has two vacancies; applicants need to reside in the Measure G area (Folsom), be an active community member at large or a member active in a business organization representing the business community located in the District.

Folsom High School—Career Technical Education (CTE) Building, Portable Classroom Installation and related Sitework

Construction of a new CTE building to house the Manufacturing and Product Development and Engineering and Architect pathways and installation of portable classroom buildings.

Theodore Judah Elementary School—Modernization

Remove existing portable media center and classroom buildings, and replace with permanent modular buildings, update restrooms, expand and reorganize parking lot and drop off/pick up area, replace/re-key to safe classroom door locks, add lunch/drop off/pick up court with shade structure, add ornamental fencing, new landscaping, add digital marquee, add disabled accessible path of travel improvements to Measure G improvement area.



CURRENT PROJECTS (continued)

Sutter Middle School

- Phase 2 Construction of a new multi-purpose building, music, food service and lunch shelter building and related site work.
- ♦ Scheduled completion summer 2019

Folsom Hills Elementary School—Modernization

Remove existing portable classroom buildings and replace with permanent modular buildings. Expand and modernize administration building and multipurpose room, modernize permanent classroom buildings, replace playground apparatus, replace shade structure, add digital marquee, add fencing/gate control at campus boundary, modernize restrooms, improve parking lot and drop off/pick up area and replace/re-key to safe classroom door locks.

COMPLETED PROJECTS

Sutter Middle School

- Phase 1A Relocate the Community Charter School to the Kitty Hawk campus, relocate on campus portable classrooms for interim housing, remove bleachers and press box, install new fire hydrant line and required ADA site upgrades.
- Phase 1B and 1C Construction of the new media center, administration building, 6th grade quad with



10 classrooms, 7th and 8th grade quad with 5 classroom, new main parking lot and reconfiguration of student drop off/pick up.
