Cordova High will provide assistance to parents of children that we serve in understanding such topics as the rigorous state academic standards, state and local academic assessments, the requirements of Title I, Part A, and how to monitor their student's progress and work with educators to improve the achievement of their children.

At Cordova High, parents are equal partners in helping their students reach their academic potential. Translation from English to a family's home language is essential to building connections between school and home. Our messaging is always sent home in English, Spanish, and Russian. Translators in the family's home language are used when conferencing with teachers or staff, by request, and with reasonable notice either through an in-person interpreter or the Language Line.
