



## 2019/20 Vista del Lago High School Registration Policy

In an effort to keep enrollment between 1,850 and 1,900 at Vista del Lago High School as approved by the Board of Education on November 15, 2018, registration priorities will be implemented for the 2019/20 school year registration period for Vista del Lago High School.

Vista del Lago will not be accepting new Inter-District Transfer Permits (outside Folsom Cordova Unified School District (FCUSD) boundaries) or new School Choice (inside FCUSD boundaries) requests at any grade level. Please note – acceptance into Vista del Lago does not guarantee a parking space. Once Vista del Lago reaches capacity, students will be redirected to Folsom High School.

Registrations will be processed in the following priority order:

1. Current Vista del Lago students in grades 9, 10 and 11 that live within the Vista del Lago attendance area or students with an existing School Choice or Interdistrict Transfer Permit will have top priority into Vista del Lago High School as long as three verified proofs of residency\* are provided and the PowerSchool Online Registration process is complete by the close of the registration period, February 19, 2019.
2. Incoming students continuing from FCUSD schools that live within the Vista del Lago attendance area that provide three verified proofs of residency\* and who have completed and been accepted through the PowerSchool Online Registration process by the registration closing date of February 19, 2019, will have the next priority and will be admitted in order based upon the PowerSchool Online Registration date/time stamp. Of this group of students, priority will be given to students with a sibling who will be attending Vista del Lago in the 2019/20 school year.

If space remains at any grade level after processing the continuing FCUSD students residing within the Vista del Lago attendance area, registrations will be processed based on the following priorities and electronic submission date, to fill that space:

3. Students not currently enrolled in an FCUSD school in 2018-19 but residing within the Vista del Lago attendance area may be admitted. This includes new students and students returning from non-FCUSD schools who reside in the Vista del Lago attendance area. Of this group of students, priority will be given to students with a sibling who will be attending Vista del Lago in the 2019/20 school year.



4. Students of full-time district employees (certificated and classified).
  5. Continuing FCUSD Vista del Lago resident students that did not complete the PowerSchool Online Registration process by the registration closing date of February 19, 2019.
  6. Any other Vista del Lago resident students that did not complete the PowerSchool Online Registration process by the registration closing date of February 19, 2019.
- \* *Per Education Code 48204.1, residency documentation includes, but is not limited to, the following:*
- *Property tax payment receipts.*
  - *Rental property contract, lease or payment receipts. Verification of rental contract or lease will be performed with the owner/leasee.*
  - *Utility service contract: SMUD, PG&E or City/County.*
  - *Pay stubs.*
  - *Voter Registration.*
  - *Government issued document such as a California Identification Card or California Driver's License.*
