2018-19 School Choice Updated Guidelines

The Folsom Cordova Unified School District has updated its guidelines regarding school choice requests. The changes were made during close and ongoing review of enrollment projections which will provide the District the flexibility to manage school capacities without having to make disruptive policy changes each year.

Deadline: Please return this form to your current school site **by Friday, January 26, 2018**. *Applications turned in after the deadline will be placed on a waitlist and reconsidered after May 1, 2018.*

Guidelines and 2018-19 Capacity: The updated guidelines apply to students residing within the District's boundary:

- Choice into FCUSD secondary schools will be considered on a space-available basis.
- ***IMPORTANT NOTE: Vista del Lago High and Sutter Middle Schools are not expected to have capacity to accommodate school choice requests in the 2018-19 school year.***
- Students of District employees (certificated and full-time classified) may be approved for school choice based on space available.
- Siblings may be grandfathered if, at the initial time of request, the older sibling currently attends and will continue to attend the secondary school requested for the next school year.

Additional info: School choice requests filed by the January 26, 2018 deadline will be considered before any Inter-district Transfer Permits (ITPs) – requests from students living outside of the FCUSD attendance boundaries – are considered. This ensures families living in our school and District boundaries are accommodated first.
